# **Program Overview**

Research has shown that psychological safety has a positive impact on creating a thriving workforce, increasing employee engagement and retention. Psychological safety is defined as the experience of feeling included, safe to learn, safe to contribute, and safe to speak up and report concerns without fear of judgement, dismissal, humiliation, or retaliation. When healthcare workers feel seen, heard, respected, valued, and safe in the workplace, it not only improves their productivity, but it also improves the quality of their patient interactions and quality of care. In this ninety-minute learning session, Dr. Clairborne defines psychological safety, its components, what threatens and destroys it, and lays out the path, tools, and strategy for how leaders can begin to create psychologically safe cultures that help their leaders and healthcare providers thrive.

# **Program Objectives**

- Define psychological safety and how it's relevant to building and sustaining a thriving workforce
- Identify the ways that toxic psychological culture harms well-being and contributes to physician and provider burnout.
- Recognize the things that threaten and destroy as well as create and enhance psychological safety.
- Identify a more trauma informed approach to creating a safety culture amongst healthcare organizations and teams.

Dr. Maiysha Clairborne is a Physician Advisor and Consultant and subject matter expert in Trauma Responsive Communication. The founder of the Mind Re-Mapping Co., she assists organizations in cultivating trust, safety, and a thriving workforce. Informed by neuroscience and emotional intelligence, Dr. Clairborne helps leaders create "safety culture" so that colleagues and employees feel seen, heard, respected, and valued. Dr. Clairborne's unique expertise is bridging the gap between knowing and doing, teaching her clients the tools to expand emotional intelligence, conscious communication & thought habits, so that they mitigate harm, become responsible for the impact of their words & behaviors, and create meaningful interactions in the workplace. A graduate of Emory University, Dr. Maiysha completed her MD at Morehouse School of Medicine,



and her Family Medicine Residency at Florida Hospital. In addition to speaking at TEDx Asheville in 2022, she is the author of the Wellness Blueprint, the co-author of Conscious Anti-Racism, and the host of the Behind Beliefs & Behaviors Podcast.
